6 Replacement licenses shall be available upon written request and the fee for issuance of a replacement license shall
7 be ten dollars (\$10.00).

3 **21 NCAC 29 .0702 DUE DATE**

4 (a) Applications for license renewal shall be submitted ~~a minimum of 30 days~~ prior to the date of license expiration.

5 (b) Licensees who submit their applications for renewal after the ~~due date but before the license expiration date~~ shall
6 ~~pay a late fee of one hundred fifty dollars (\$150.00), in addition to the license renewal fee set forth in Rule .0404 of~~
7 ~~this Chapter~~ date on which the license expires, but within twelve months, thereafter shall pay a late fee of three hundred
8 dollars (\$300.00), in addition to the license renewal fee of three hundred dollars (\$300.00). Licensees who apply to
9 reinstate their license more than twelve months after the date on which the license expires shall pay a reinstatement
10 fee of two hundred fifty dollars (\$250.00), in addition to the late fee of three hundred dollars (\$300.00) and the license
11 renewal fee of three hundred dollars (\$300.00).

12 (c) The Board shall deem applications submitted on the date of their postmark or upon receipt by staff at the Board's
13 offices, whichever is earlier.

3 **21 NCAC 29 .0703 REINSTATEMENT OF EXPIRED LICENSE**

4 (a) ~~Licenses that have been expired for more than one year may be eligible for reinstatement.~~ A licensee with an
5 expired license may apply for reinstatement only if he or she has completed at least eight contact hours of continuing
6 education within one year preceding the application.

7 ~~(b) Applicants for reinstatement shall pay the following fees:~~

8 ~~(1) A license renewal fee as set forth in Rule .0404 of this Chapter;~~

9 ~~(2) A late fee as set forth in Rule .0702 of this Section; and~~

10 ~~(3) A reinstatement fee of one hundred fifty dollars (\$150.00).~~
